



Health & Safety Code for accredited individuals

1. Agreeing to the Health & Safety COVID-19 Protocol

Accreditation to the event as well as access to official event-related locations are subject to your consent to the Health & Safety COVID-19 Protocol (hereafter "the Protocol"). By applying for accreditation to the Eurovision Song Contest 2021 and accepting your accreditation card you confirm to have read, understood and consent to this Code and the Health & Safety COVID-19 Protocol. You accept that failure to abide by these rules will lead to withdrawal of accreditation and denial of access to the event and its official premises.

2. Applicability

The Protocol applies to all accredited individuals attending the event, whereas at the venue (Ahoy) or any other official event-related location (Eurovision Village, official hotels, within official transportation means, etc.). The Protocol is publicly available (e.g. on Eurovision.tv, Songfestival.nl and in the STEAM21 app).

Testino

By signing this Code you give explicit consent to comply with regular COVID-19 testing in accordance with instructions of the Host Broadcaster. Upon a valid negative test result, your accreditation card will be activated for the duration of the validity of the test. Upon a positive test result, you will be required to immediately return your accreditation card. Testing will be conducted by a third party, to which the third party's Privacy Policy applies. The Host Broadcaster will not process personal medical information.

- 4. **Reporting breach:** Any breach of the Protocol must be reported immediately to the Health & Safety Manager of the Host Broadcaster or the EBU Security Advisor.
- Consequences of (suspected) breach: Breach of the Protocol, or suspicion thereof, may, at the sole discretion of the Health & Safety Manager of the Host Broadcaster or the EBU Security Advisor, lead to immediate withdrawal of accreditation and removal from the venue.
- 6. **Changes:** The provisions within the Protocol may be subject to change at any time based on local and national authorities, or at the discretion of the EBU and/or the Host Broadcaster. Accredited individuals should continue to abide by the updated Protocol at all times. Please consult Eurovision.tv, Songfestival.nl or the STEAM21 app for accredited individuals regularly to check for updates.
- 7. Liability: Although the EBU and Host Broadcaster have done the utmost to secure the reliability, correctness and completeness of this document, the organizers do not accept any liability for any damages, direct or indirect, resulting from inaccuracies or omissions in the aforementioned documents. No rights can be derived from this Code or the Protocol.

8. Withdrawal of consent

Withdrawal of consent to this Code and/or the Health & Safety COVID-19 Protocol will lead to loss of accreditation.

Privacy Notice

Introduction

This Privacy Notice tells you what to expect us to do with your personal information when you make contact with us or use one of our services. The Host Broadcaster takes the protection of your data seriously and take appropriate measures to prevent any abuse, loss, unauthorized access, undesired disclosures and unauthorized changes.

What personal information do we collect?

Most of the personal information we process is provided to us directly by you through Accredion for one of the following reasons:

- You wish to attend, or have attended, Eurovision Song Contest 2021.
- You are representing your organization.

On which legal basis do we collect personal information?

The legal bases for processing by the Host Broadcaster will be:

- Where it is necessary for our legitimate interest.
- Where it is in the interest of public health / vital interests (Article 9 (2) GDPR).

Do we share your personal information?

The Host Broadcaster will only share your name and email address to make an appointment for a Covid-19 test at the testing facility company (to be announced).

The Host Broadcaster will not share your personal data with the other public authorities, like Rotterdam-Rijnmond Municipal Health Service (GGD), National Institute for Public Health and the Environment (RIVM) or emergency services unless it is necessary or we are under a duty to disclose your personal information in order to comply with any legal obligation.

To enable the Covid-19 testing to be completed by the testing facility company they need to process personal information, including sharing of personal information where they have a legal obligation. The information will only be stored securely. The testing facility company is the Data Controller for the information required for processing the test and undertaking any actions which are needed to ensure they meet their public health and safeguarding legal obligation. The testing facility company will only keep your personal information for as long as is necessary for the purpose for which they are processing it. For more information and/or access to your personal information we refer to the privacy policy of the testing facility company.

The personal information associated with test results will only be shared with you.

Personal information relating to positive test results will only be transferred to the Municipal Health Services by the testing facility company and they will use this information for contact trancing activities as well as statistical and research purposes. The Host Broadcaster will not receive or record your test results and therefore this information cannot be shared with anyone.
